Seminole County Bar Association Legal Aid Society opened our doors in 1975.

We provide high quality civil legal services and education free of charge to disadvantaged and low income residents of Seminole county so as to protect their personal safety, promote their self-sufficiency, and improve their quality of life.

For many, we provide their only access to the judicial system to resolve critical legal problems.

We assist:

- Survivors of domestic violence
- Veterans, who need to resolve a civil legal matter
- Relatives seeking custody of minor children when parents are addicted to opioids
- Families of disabled children requesting appointment as guardian advocate when their child turns 18 years of age
- Elderly people seeking legal help to preserve their housing
- Disabled foster youths needing to obtain Medicaid waivers
- Unemployed persons seeking the sealing and expungement of an eligible crime to obtain a job
- Economically disadvantaged parents wanting to obtain a safe timesharing plan for their child and support to financially care for the child

In addition, we also administer the pro bono attorney project in Seminole County which expands our ability to help additional Seminole County residents with their legal needs. We also participate in several special legal projects, members of domestic violence and child abuse prevention taskforces, and on the Seminole County Affordable Housing Advisory Board.

All legal services are provided in Seminole County to benefit our clients, their children and our community.



2018-2019 FISCAL YEAR ACCOMPLISHMENTS

Our services are provided through the unified efforts of excellent pro bono attorneys, experienced staff attorneys, devoted and compassionate support staff, volunteer college students, and strong leadership of a dedicated board of directors. As a result of this collaboration, we can provide legal assistance in various areas of the law such as family, housing, guardianship of the disabled, immigration, juvenile, elder, consumer, and sustain several legal workshops and legal advice clinics.

This past fiscal year, our volunteers and staff attorneys served **962 families**, which includes **1,201 children** with their legal needs. We obtained court orders establishing child support in the amount of **\$356,154.05** to sustain vulnerable families. Volunteer attorneys donated pro bono legal services valued at an estimated **\$207,060** and contributed **\$27,100** in lieu of service donations. ASSISTING VICTIMS OF CRIME WITH THEIR CIVIL LEGAL NEEDS

Being poor dramatically increases a woman's chances of being abused. One analysis of data collected by the Department of Justice's Bureau of Justice Statistics showed that women in the lowest income households experience seven times the rate of abuse suffered by women in the highest income households. Likewise, women who experience food and housing insecurity experience a significantly higher incidence of rape, physical violence, or stalking by an intimate partner.

Studies have found that availability of civil legal aid can be effective in reducing rates of violence, and even more effective than alternative interventions such as the provision of shelters or counseling services. Increased funding to enhance the availability of civil legal services to low-income families can lower the societal costs of domestic violence, generating substantial economic benefits. Legal services help survivors with practical matters (such as protective orders, custody, and child support) appear to present survivors with real, long-term alternatives to their relationships.

Our free civil legal project is designed to build the economic self-sufficiency of the survivors and conversely lower the societal costs of domestic violence, generating substantial economic benefits. We assisted **849 families** who were victims of crime with their civil legal needs.



Tamara's Story

Tamara, a survivor of domestic violence applied for assistance with our office after her estranged husband physically abused her. Her husband then moved out of the state, leaving her and the parties' minor child without sufficient means to pay their basic living expenses. Tamara, a now single mother had been diagnosed with Stage IV Congestive Heart Failure and continued functioning with the use of a mechanical heart pump, while waiting for a heart transplant. Unable to work, Tamara had applied for but was initially denied Social Security Benefits. Desperate for help and direction, Tamara applied for assistance. Our office provided full legal representation for Tamara's dissolution of marriage action. We obtained a Final Judgment of Dissolution of Marriage providing Tamara with majority timesharing of the parties' minor child, child support (beyond the age of emancipation—by 1.5 years) and alimony. Now Tamara and the child are living without the continued fear or concern of unpaid bills and the loss of their home.



AFFORDABLE HOUSING PROJECT

Fighting the Affordable housing problem.

Central Florida (including Seminole County) is one of the worst metropolitans in the nation for affordable housing. We rank first among the largest metropolitan areas for the most severe affordable housing beating Las Vegas, Los Angeles and Houston. There only exists 13 affordable and available housing for every 100 extremely low income renters. Hasty relocations, disrupts employment and hinders the education of children creating instability and homelessness. Seminole County Legal Aid helped **100** families preserve their housing or help soften the consequences when housing disruptions are unavoidable.



Alissa's Story

Alissa, a single mother, rented a room in a beautiful home in Seminole County. She was very happy that she could provide a nice home in a good neighborhood and good school for her daughter. After a few months, the landlord raised her rent. Alissa struggled to pay the rent because she did not want her daughter to have to relocate schools and the neighborhood. Her salary from working full time at a local hospital provided just enough income to meet the increased rental demands. She went to the local food pantry to obtain donations of food and household goods to stretch her budget.

One day when she returned from work, she found a summons and complaint requesting her removal from the home despite Alissa just paying her monthly rental obligation. The complaint alleged Alissa was a transient and had no rights to stay in the home and needed to move. Alissa sought legal assistance from one of our staff attorneys. Alissa found out that her landlord was actually not the owner of the home but was only just a tenant renting the home and was not allowed to sublease any portion of the home. The attorney immediately reviewed the legal documents and filed the necessary pleadings with legal defense seeking to dismiss the court case. After a hearing in court, the judge dismissed the case and told the Landlord that she needed to provide adequate legal notice and follow proper court procedure. Alissa now has sufficient time to find another home in a good location and has learned to be more discerning when choosing another location.



DISABLED CHILD LEGAL PROJECT

We assist families establish guardian advocacy when their developmentally challenged child reaches the age of 18. Last year we assisted **24** families establish guardian advocacies for their children. We also assisted **53** families complete their required annual plans. We also developed an informative video concerning guardian advocacy which is broadcast on our website.

These families struggle in meeting the special needs of their children and need our help to lighten their responsibilities in establishing guardian advocacies to secure their children's future and well being.



Marta's Story

Marta, a senior citizen, has been caring for her autistic grandson, Kyle, since he was 12 years old. His parents were young and could not manage their son's special needs. Neither parent visits or support their son. Marta has been his primary and only caregiver. Marta was distraught when she arrived at our office. She said that Kyle's guidance counselor had told her that Kyle had to leave the school because she did not have legal custody of Kyle. She was very worried. She wanted Kyle to complete his senior year at his local high school and earn his high school diploma. An attorney was immediately assigned to her case and contacted the school's attorney to determine what issues or problems existed prohibiting Kyle's continued attendance of high school. The attorney determined that there was a misunderstanding and that the school staff was merely requesting Marta to be appointed guardian of Kyle so that she had the power to sign necessary special education documents upon Kyle's upcoming 18th birthday.

The attorney immediately prepared and filed the necessary pleadings with the court needed for Marta to become appointed Guardian Advocate of Kyle. The judge reviewed the documentation and the recommendation of the court appointed attorney for Kyle and appointed Marta as Guardian Advocate. Now Marta has full power and authority to advocate for Kyle in school and make sure that he graduates with his high school diploma. Kyle is also very happy that he will continue to live with his grandmother. He had been very worried that the state would remove him from his grandmother.



FIGHTING THE OPIOID CRISIS

According to the Seminole County Sheriff's office about 650 people in Seminole County overdosed on Opioids, and 82 died in 2018—a 32% increase in deaths in 2 years. Every day, misuse and addiction to opioids destroys families. We see babies born addicted to opioid, children neglected or abandoned, and families torn apart. We strive to fight the effects of the opioid crisis on children by assisting responsible relatives obtain temporary custody of neglected or abandoned children while their parents fight their addictions and stabilize their lives. This past year, we have assisted **20 families** obtain temporary legal custody allowing our clients to provide a happy and healthy life to the children trapped in this epidemic.



Thomas' Story

Thomas walked into our office and stated he had an emergency and needed help. He was about to be deployed to the Middle East within the next 2 weeks and needed help in seeking the appointment of his mother in law as temporary custodian of his young autistic son while he was on active orders. His wife is addicted to opioids and was just committed for treatment. He expressed the importance of going overseas with his team as they had specially trained for the important mission and he did not want to let down his team but wanted to be assured that his son was well taken care of while he served our country. He told the front office staff that he had been to the law library to research what he needed to do legally but determined that the process was too involved to proceed on his own. The librarian suggested going to the legal aid office to seek assistance.

Recognizing his urgency, Thomas was immediately assigned to a staff attorney, who turned her attention to drafting the necessary pleadings and securing a court order to appoint the temporary custodian for his special needs son. Fortunately, the court order was obtained, and Thomas was able to deploy overseas with his team. Thomas was very grateful for our legal services and expressed that now he was able to focus on his mission knowing his son's special needs could be legally addressed by his mother in law.



PRO BONO ATTORNEYS ARE AWESOME

Last fiscal year, our pro bono attorneys assisted **111 indigent clients** donating legal services with a **value of \$207,060** to help vulnerable families in Seminole County.

Attorneys also made monetary contributions in the amount of **\$27,100** to support our program. The volunteer attorneys held **12** veteran legal advice clinics; **11** sealing and Expungement Legal Workshops.

Pro Bono Attorneys held **36** family law advice clinics helping self represented litigants with their cases this year.

Our pro bono attorneys helped with our school supply drive and donated **150** backpacks full of school supplies for vulnerable Seminole County Children. Over 50% of Seminole County students are on the free or reduced lunch program, this means that over 33,000 students are unable to afford lunch at school. Of those 33,000 there are over 1,700 students identified as homeless.

Our pro bono attorneys collected hurricane supplies to assist the Hurricane Dorian victims of the Bahamas.

VETERAN'S LEGAL ADVICE CLINIC

Javier's Story

Javier attended the Veterans Legal Clinic to obtain free legal advice. Noting that Javier needed further assistance due to his combat injuries, he was assigned for full legal representation. Javier is a combat wounded veteran who was stationed in Afghanistan and hit with enemy fire; as a result he is disabled. He was seeking a divorce from his wife who was living in Puerto Rico in his home which he had purchased before the marriage. He had no idea how to go about filing for divorce, or how he would get his wife served with the divorce papers since she was not living in Florida. He was also concerned that his wife could make a claim on the home. He consulted with the staff attorney who conducts the monthly veterans clinic and the attorney agreed to help Javier with his divorce and to represent him. The staff attorney took the necessary steps to secure service on the wife in Puerto Rico by using a private process server, and then appeared in court with Javier to get his divorce. At the trial, Javier's home in Puerto Rico was granted to him exclusively, and he was officially divorced.

Javier was extremely thankful and appreciative of the help Seminole County Legal Aid gave to him.



SEALING AND EXPUNGEMENT LEGAL WORSHOPS



Volunteer Attorney Chmelir

Presenting Sealing and Expungement Legal Clinic at Goodwill Job Connection Center

For people, who have a criminal record, there are many roadblocks to employment as employers are reluctant to hire people with criminal records. The Florida Department of Law Enforcement reported that over 3,169,593 residents in Florida have dispositions other than conviction (e.g., adjudication withheld, acquitted, or no disposition reflected in the criminal history file). This type of record creates an insurmountable barrier to employment. Ultimately these records become a life sentence of under or unemployment.

Every month, our Pro Bono Program hosts a Sealing and Expungement Legal Workshop at the Goodwill Job Connection Center. The curriculum for the seminar was developed by a pro bono attorney. She developed an extensive and informative power point presentation that is used by the other pro bono attorneys teaching the class.

The pro bono attorneys teach job seekers at the Goodwill site of the Sealing and Expungement process and how to Seal or Expunge a record without having to hire a private attorney. After the presentation, the pro bono attorneys meet with each job seeker and review their individual cases and dispositions and notify the job seeker if they would be eligible of Sealing or Expunging their record. Packets are provided, containing the FDLE application for each person in attendance of the class, along with all the necessary "pro se" documents for future use. We assisted approximately **40 job seekers** this past fiscal year at the workshop at GoodWill Job Connection.

Embrace Families proudly serves as the state-designated lead agency for child welfare services in Orange, Osceola and Seminole Counties, Florida. The organization works to prevent child abuse and neglect, to strengthen families, and to care for our community's children in foster care. Their goals are to ensure safety, provide permanency, and maintain the well-being of the children served by child welfare.

The goal of our diversion program is to help stabilize and strengthen families before the need for removal occurs. Embrace Families partners with our legal aid program in identifying families who need free legal services to stabilize their families. Often a responsible relative is identified, who needs legal assistance to establish custody of a neglected or abandoned child, while their parents fight the opioid addiction and stabilize their home. Our joint efforts help bring stability and wellbeing to the lives of the children.
