Shared Decision Making

Travel is permitted only to countries that are signatory members of the Hague Convention on Civil Aspects of Child Abduction.

If the other parent travels to such a country that is not a member of the Hague Convention, they shall provide the non-traveling parent an open-ended, round trip airline ticket in case the child(ren) is/are not returned.
